CUSTOMER SERVICE AND SERVICE HOURS PER MONTH

Genius Programs offers customer support for our services via phone, e-mail and web chats from 8AM to 5PM central time on normal business days. We are closed on Federal and most bank holidays.

Unless covered by a separate software use agreement, customer service hours relating to non-system issues will be limited to 10 hours per month. Any hours after that will be billed at a rate of \$50 per hour in whole-hour increments. You will be notified via e-mail to the accounts listed in your sponsor administrator uses when you are approaching your monthly limit.
