

TERMS OF SERVICE AGREEMENT

PLEASE READ THE FOLLOWING TERMS OF SERVICE AGREEMENT CAREFULLY. BY ACCESSING OR USING OUR SITES AND OUR SERVICES, YOU HEREBY AGREE TO BE BOUND BY THE TERMS AND ALL TERMS INCORPORATED HEREIN BY REFERENCE. IT IS THE RESPONSIBILITY OF YOU, THE USER, CUSTOMER, OR PROSPECTIVE CUSTOMER TO READ THE TERMS AND CONDITIONS BEFORE PROCEEDING TO USE THIS SITE. IF YOU DO NOT EXPRESSLY AGREE TO ALL OF THE TERMS AND CONDITIONS, THEN PLEASE DO NOT ACCESS OR USE OUR SITES OR OUR SERVICES. THIS TERMS OF SERVICE AGREEMENT IS EFFECTIVE AS OF 10/04/2022.

ACCEPTANCE OF TERMS

DESCRIPTION OF WEBSITE SERVICES OFFERED

The Site is a website interface and companion mobile application which has the following description:

A cloud based, website and mobile application interface for tracking events of participants in the USDA CACFP (Child and Adult Care Food Program) and/or SFSP (Summer Food Service Program) to be used by Day Care Homes and Sponsoring Organizations, Child Care Centers and Sponsoring Organizations, At-risk Afterschool Care Centers and Sponsoring Organizations, Adult Day Care Centers and Sponsoring Organizations and Emergency Shelters and Sponsoring Organizations.

Any and all visitors to our site and users of the website applications and/or companion mobile application(s) shall be deemed as "users" of the herein contained Services provided for the purpose of this TOS.

The user acknowledges and agrees that the Services provided and made available through our website and applications, which may include some mobile applications and that those applications may be made available on various social media networking sites and numerous other platforms and downloadable programs, are the sole property of Genius Programs. At its discretion, Genius Programs may offer additional website Services and/or products, or update, modify or revise any current content and Services, and this Agreement shall apply to any and all additional Services

and/or products and any and all updated, modified or revised Services unless otherwise stipulated. Genius Programs does hereby reserve the right to cancel and cease offering any of the aforementioned Services and/or products. BILLING CYCLE AND BILLABLE EVENTS

Genius Programs will invoice sponsors on the 15th of the following month whenever attendance and/or meal counts have been entered at any time and in any quantity during a month. We will NOT bill you if only menus, participants and other information is entered. A "billable event" constitutes an attendance count or meal count for any participant during the month. If you believe that an attendance and/or meal count was entered in error, you may notify us of this and delete the record(s) on our system and we may refund the invoiced amount or apply it to your future invoices.

CUSTOMER SERVICE AND SERVICE HOURS PER MONTH

Genius Programs offers customer support for our services via phone, e-mail and web chats from 8AM to 5PM central time on normal business days. We are closed on Federal and most bank holidays.

Unless covered by a separate software use agreement, customer service hours relating to non-system issues will be limited to 10 hours per month. Any hours after that will be billed at a rate of \$50 per hour in whole-hour increments. You will be notified via e-mail to the accounts listed in your sponsor administrator uses when you are approaching your monthly limit. If there is a genuine system issue, (i.e. our system is stuck or is the root cause of the issue) those hours will not count against your monthly total. We do not own and therefore can not fix or be held responsible for issues related to connectivity including but not limited to poor: Wi-Fi signal strength, devices with limited range, service interruptions caused by any of the carriers between our server and your location.

COOKIES

We employ the use of cookies. By using Genius Programs' website and mobile application(s) you consent to the use of cookies in accordance with Genius Programs' privacy policy.

DATA RETENTION

Any data records (Attendees, Menus, Meal Logs, Reports, Claims, etc.) entered into Genius Programs system shall be maintained and access provided to any user(s) that were listed on the account at the time of cancelation for a period of not less than three (3) years and three (3) months from the time a subscription to our services is canceled. You may view this information anytime you wish through your standard login credentials. No changes, revisions, additions, subtractions or alterations may be made to this data by any user(s) after a subscription has been canceled. Genius Programs is not under any obligation to delete or destroy the data after the above stated time frame, but may do so without informing you of such actions prior or post to their being carried out.
